

WHO IS SUITABLE TO BE A MODEL FOR THE FOUNDATION BOTULINUM TOXIN AND DERMAL FILLER COURSE

DELEGATE INFORMATION

As a course delegate on the THE FOUNDATION BOTULINUM TOXIN AND DERMAL FILLER COURSE you should bring along your own model to work on.

If you can't find a model let us know asap.

It is important to discuss with your model in advance what is required of them.

This will ensure there are no issues regarding consent on the day of treatment.

TREATMENTS COVERED

On our Foundation Botulinum Toxin and Dermal Filler course the treatment areas you will be working on are as follows:

3 Areas of Botulinum Toxin Type A

Areas: Crow's feet, forehead and frown lines

Product: Up to 50 units of Bocoture (Merz)

Dermal Fillers

Area: Lips (to add volume and definition)

Product: Up to 1ml of RHA2 (Teoxane)

Please find a suitable model who will consent to having both treatments on the day or you will not be able to pass your practical.

You can only use one model.

SUITABLE MODELS

What Makes a Model Suitable:

- Over 18
- In good health
- Has suitable treatment areas (e.g. can see wrinkle lines)
- Has had treatment before / Is comfortable with needles

What Makes a Model NOT Suitable:

- Pregnant or breastfeeding
- Has had botox in the last 3 months
- Has had lip filler in the last 6 months
- Has an active cold sore (please note if your model has a cold sore on the day of training, they will not be able to receive treatment).
- Scared of needles

Please note models will be required to fill in a medical history form so we can ensure there are no medical conditions or medications which rule them out.

Please refer to our model terms and conditions regarding patient suitability and medical exemptions etc.

SELECTING A MODEL

Lip Filler Treatment

You must select a patient who will benefit from having the treatment. Patients with recent existing lip filler or very full lips from previous treatments are not suitable.

MODEL PHOTOS

We require all models to send in photos ahead of time so they can be checked by our training manager. You should get your model to EMAIL us within 1 week of booking your course – office@inspiredcosmeticttraining.com

Please advise your model to send us the follow photos:

- Front of face, relaxed
- Front of face, raised eyebrows

- Front of face, frowning/furrowed brow
- Side of face, scrunched eyes
- Close up of lips

WHAT YOU NEED TO TELL YOUR MODEL

Time: This is advised on your delegate further information email.

They should be there for around an hour, however, please ensure they know it could be **longer due to being a training course.** We generally ask models to allow for 2 hours.

Please tell them to bring some reading materials/phone etc.

Please advise your model:

- They are not able to wear make up on the day
- They must consent to both botox and filler treatment on the day
- They will not be able to drink alcohol after treatment
- They must consent to pictures being taken on the day and know these may be used on our website or social media for educational purposes
- To complete all 5 model forms ASAP and to read them thoroughly
